

Binex has been selected as Costco Wholesale (Korea)'s exclusive U.S. freight forwarder and P.O. Management Service Provider for 22 consecutive years since 2000.

Binex has been providing comprehensive logistics service for Boeing Aerospace to export military hardware to S. Korean Arm Services since 2005. Their shipments normally contain national defense cargoes that are highly sensitive and license required materials, extreme care, and special handling. Binex has gone through a series of interviews, inspections by Boeing, and we meet all their requirements between the U.S. and Korean governments.

Customer information systems such as Binex's Informative Software Systems (ISS), Transportation Management Systems (TMS), and Warehouse Management Systems (WMS) are vital in providing customers with on-time tracking information. In 2004 Binex launched its own state of the art information systems, which, not only provides software for all internal use, but provides real time online tracking to all our customers for all their import/export cargoes whether it's on ocean, in the air, or at rail. Our customers can access and print documents such as B/L, arrival notice, and an invoice from our system.

Binex started to focus on perishable export shipments from 2003, and today our company is known as one major perishable freight forwarder in the industry. We started with Cherry air shipments from Washington and California states, and now we handle more than 800 containers load per year on fresh fruits and produce such as Citrus, Pomegranates, Grapes, Broccolis, and etc. Today, approximately 40% of U.S.-grown Cherries, and 70% of U.S.-grown Pomegranates consumed in Korea are shipped by our company.

## Automated Manifest System (AMS) & Importer Security Filing (ISF)




The Automated Manifest System (AMS) is a multi-modular cargo inventory control and release notification system for sea, air, and rail carriers. AMS speeds the flow of cargo and entry processing and provides participants with electronic authorization to move cargo prior to arrival. AMS facilitates the intermodal movement and delivery of cargo by rail and trucks through the In-bond system. AMS reduces reliance on paper documents and speeds the processing of manifest and waybill data. As a result, cargo remains on the dock for less time, participants realize faster tracking, and Customs provides better service to the importing community. Our AMS system allows us to submit AMS filing for our customers and participate in the U.S. Customs AMS cargo release notification system for rapid identification and release of shipments.

The **Importer Security Filing (ISF)** or 10+2 rule by USCBP states that it is the importer's responsibility to submit ISF to the U.S. Customs at least 24hours prior to cargo loading onto the vessel at departing port. Failure to comply with the new rule could result in monetary penalties as well as delay of cargo. ISF requires submission of certain cargo information to U.S. Customs in advance. Our ISF system allows us to submit filing for our customers to meet the new regulation.

Our experienced Customs House Brokerage (CHB) team represents you in dealing with the Customs and ensures seamless compliance and total visibility for your international shipments.
